DIRECTIVE FOR OBLIGATORY PUBLICATION REQUIREMENTS OF GRADUATE PROGRAMS

FIRST CHAPTER

Purpose, Scope, Basis, Definitions and Abbreviations

Purpose

ARTICLE 1- (1) Purpose of this directive is to regulate the principles regarding the obligatory publication requirements, which the students enrolled in graduate programs of Istanbul Aydın University must fulfil for graduation.

Scope

ARTICLE 2- (1) This directive covers all the information regarding the obligatory publication requirements, which the students enrolled in thesis master's, PhD, and proficiency in arts programs of Istanbul Aydın University must fulfil for graduation.

Basis

ARTICLE 3- (1) This directive is prepared according to:

- a) Article 44 of the Higher Education Law No. 2547 dated 4/11/1981,
- b) the Presidency of Higher Education Council Graduate Education Regulation no. 29690 and dated 20 April 2016,
- c) Article 10, 27 and 37 of the Aydın University Graduate Teaching and Examination Regulation.

Definitions and Abbreviations

ARTICLE 4 - (1) The abbreviations in this directive stands for:

- a) ID: Institute Department,
- b) Institute: Istanbul Aydın University Graduate Education Institute,
- c) IB: Institute Board
- d) IAU: Istanbul Aydın University,
- e) Rector: The rector of Istanbul Aydın University
- f) Senate: The senate of Istanbul Aydın University
- g) IUC: Interuniversity Board Presidency
- h) YÖK: Council of Higher Education.

SECOND CHAPTER

Publication Obligation of Graduate Students

Thesis Master's Programs

ARTICLE 5-(1) The students enrolled in IAU thesis master's programs, must fulfil the publication obligation defined in the subclause 4 of the article 10 of the IAU Graduate Education Regulation in order to graduate. Students who have not fulfilled the obligatory

publication requirement for graduation are not accepted to the thesis defense until they have fulfilled the publication requirement, even if they complete the thesis.

- (2) According to the subclause 4 of the article 10 of the IAU Graduate Teaching and Examination Regulation, in order to graduate, students of thesis master's programs are obliged to:
- a) have at least one article published or accepted for publication in a national or international peer-reviewed journal, or
- b) have at least one paper presented in a national or international peer-reviewed scientific meeting, criticized, discussed and published or accepted for publication in abstract or full text booklet, or
- c) have a book or a chapter related to the student's field published in a national or international publishing house that is active for at least 2 years.
- (3) Students who want to count the book or the chapter they have written as a graduation publication requirement must submit at least one printed original copy of the book to the Institute. The studies carried out by students who have not deliver the printed original copy of the book to the institute is not counted for the graduation publication requirement.
- (4) Articles prepared with the thesis advisor or another faculty member(s) can be counted as graduation publication requirement.
- (5) In order for the articles to be counted as publication requirement, they must be published with a single author.
- (6) In order for joint studies to be counted as graduation requirement, they must be carried out by students enrolled in different programs. For this type of study, the number of authors cannot exceed three. The subject of the study must include the content of all of these students 'programs. These publications can be counted as graduation publication requirement for students who prepare the study, provided that they fulfil other requirements.
- (7) Articles published in journals that include both peer-reviewed and non-peer-reviewed articles, can be counted as graduation publication requirement provided that the article is proven to be peer-reviewed and other requirements are fulfilled. Articles that are not peer-reviewed are not counted as a graduation publication requirement.
- (8) In order for an article to be counted as graduation publication requirement, it must include "Istanbul Aydın University" or the e-mail account with "@stu.aydın.edu.tr" domain. Articles that do not include above mentioned IAU addresses are not counted as graduation publication requirement.
- (9) The same rules apply to articles published or accepted for publication in the journals published by the IAU or in the scientific meeting organized by the IAU.

Doctoral Programs

ARTICLE 6 - (1) The students enrolled in IAU Doctoral programs, must fulfil the publication obligation defined in the subclause 1 of the article 27 of the IAU Graduate Education Regulation to graduate. Students who have not fulfilled the obligatory publication requirement for graduation are not accepted to the thesis defense until they have fulfilled the publication requirement, even if they complete the thesis.

- (2) According to the subclause 1 of the article 27 of the IAU Graduate Teaching and Examination Regulation, to graduate, students of doctoral programs are obliged to make their publications according to the compulsory article criteria determined by IUC for Associate Professorship. Publications excluding the criteria specified in the table are not accepted as graduation requirement.
- (3) Each student is responsible for the first mandatory requirement of the IUC Associate Professorship publication conditions in their field of expertise, which are in effect at the time their article is accepted for publication.
- (4) In order for the articles to be counted as publication requirement, they must be published with a single author.
- (5) In order for joint studies to be counted as graduation requirement, they must be carried out by students enrolled in different programs. For this type of study, the number of authors cannot exceed two. The subject of the study must include the content of all of these students 'programs. These publications can be counted as graduation publication requirement for students who prepare the study if they fulfil other requirements.
- (6) Articles prepared with the thesis advisor or another faculty member(s) can be counted as graduation publication requirement.
- (7) In order for an article to be counted as graduation publication requirement, it must include "Istanbul Aydın University" or the e-mail account with "@stu.aydın.edu.tr" domain. Articles that do not include above mentioned IAU addresses are not counted as graduation publication requirement.
- (8) The same rules apply to articles published or accepted for publication in the journals published by the IAU.

Doctor of Arts Programs

- **ARTICLE 7** (1) The students enrolled in IAU Doctor of Arts programs, must fulfil the publication obligation defined in the subclause 1 of the article 37 of the IAU Graduate Education Regulation to graduate. Students who have not fulfilled the obligatory publication requirement for graduation are not accepted to the thesis defense until they have fulfilled the publication requirement, even if they complete the thesis.
- (2) Each student is responsible for the first mandatory requirement of the IUC Associate Professorship publication conditions in their field of expertise, which are in effect at the time their work (article, book, exhibition, project, recital, concert, representation, etc.) is accepted.
- (3) Articles prepared with the thesis advisor or another faculty member(s) can be counted as graduation publication requirement.
- (4) In order for the articles to be counted as publication requirement, they must be published/presented with a single author.
- (5) In order for joint studies to be counted as graduation requirement, they must be carried out by students enrolled in different programs. For this type of study, the number of authors cannot exceed two. The subject of the study must include the content of all of these students 'programs. These publications can be counted as graduation publication requirement for students who prepare the study if they fulfil other requirements.

- (6) In order for an article to be counted as graduation publication requirement, it must include "Istanbul Aydın University" or the e-mail account with "@stu.aydın.edu.tr" domain. Articles that do not include above mentioned IAU addresses are not counted as graduation publication requirement.
- (7) The same rules apply to studies published/accepted for publication in journals published by IAU and studies presented at events organized by IAU.

THIRD CHAPTER

Miscellaneous and Final Provisions

Miscellaneous

ARTICLE 8 - (1) In cases where this directive does not apply, the provisions of the Istanbul Aydın University Graduate Teaching and Examination Regulation are applied.

Effectiveness

ARTICLE 9 - (1) The provisions of this Directive are entered when accepted by the Istanbul Aydın University Senate.

Enforcement

ARTICLE 10 - (1) The provisions of this Directive are executed by the Rector of Istanbul Aydın University.
