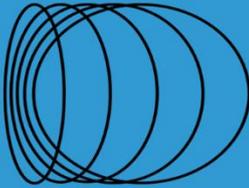




Press Reflections of the Conference on Corporate Governance Practices in Business and Academic Perspectives

The Conference on Corporate Governance Practices from the Business World and Academic Perspective, which we held on October 19, 2018, was published as news in many national presses. In the news, which is generally given as "IAU Raised Corporate Governance Rating", "Aydın University has increased its corporate governance rating, which it received last April, within 6 months. The certificate confirming the success was presented at the ceremony held before the panel. Istanbul Aydın University, the first university in Turkey to have a corporate governance rating, achieved a first by increasing its grade within 6 months before the end of a rating period. Prior to the panel titled "Corporate Governance Practices from the Business World and Academic Perspectives", the certificate presented by Sühan Seçkin, Chairman of Saha Rating Board of Directors, was presented by Rector Prof. Dr. Yadiğar İzmirli and Chairman of the Board of Trustees Dr. Mustafa Aydın received it.
